ADOPTION CONTRACT

Angel of Hope Animal Rescue (AOH) is an organization providing for the adoption of rescued animals to prospective adopters. The adopter agrees to follow the contract as stated in whole.

1. If you have any concerns about the health of this animal, please **STOP** the adoption process now! Reach out to AOH we will put the pet on hold, have our vet team evaluate the pet's health and reach out to you with an update. Please remember you will be responsible for all vet care once adopted. _____
2. Adopter agrees that this pet will be a indoor pet and will provide them with proper food, water, veterinarian care and loving attention. _____ (MN State Statute 346.16 and 346.39)
3. Adopter agrees that if at any time, they are unable to keep or care for this animal, the Adopter of record will contact AOH to discuss possible options. AOH will do it's best to take the pet back into our program, if it is not possible, we will assist with other possible options. Returning pets will be set up by appointment during our business hours at our Dayton, MN location. _____
4. AOH recommends to have this pet checked by a licensed Veterinarian within fourteen days of the adoption at their own cost. This is to allow you to return during refund period if you find it necessary. _____
5. If the adopted pet is returned within two weeks of adoption, adopter may be eligible for a refund less a \$25 processing fee. Checks are processed through our accountant and will be mailed to the adopters address on file. Please allow 7-10 business days after a pet is returned for the check to arrive. _____
6. Adopter agrees that AOH has limited, if any, knowledge of an animal's previous environment and therefore is not responsible for the longevity of health, medical conditions or temperament of the animal. There will be an adjustment period for animals. Please remember to be patient, consistent in the introductions and understanding. _____
7. Angel of Hope will not be held liable or responsible for any veterinary costs after adoption. _____
8. **AOH provides 30 day pet insurance to all adopters.** This insurance is at no charge to the adopter. Adopter agrees to activate the insurance the same day of the adoption because it takes 24 hours for insurance to be active. A Pamphlet is included in your adoption packet, and has the steps to activate the policy. Contact info is also in the box below. _____

AOH is not liable for any present or future action of this animal. Adopter agrees to absolve and indemnify AOH and its agents for any and all losses or expenses related to this pet. _____
11. Adopter agrees to pay all attorney's fees and court costs should there be any legal action regarding the pet. _____
